Executive Summary

This policy resolution would establish a "Vision Zero" Policy, and set a goal of eliminating traffic deaths and serious injuries in Columbia by 2030.

Discussion

In May 2015, the Council established a Mayor's Task Force on Pedestrian Safety due to traffic deaths and serious injuries throughout Columbia within a time span of a few months. The Task Force was tasked to analyze the problem and provide recommendations on what could be done to decrease collisions between automobiles and pedestrians in terms of education and community outreach, law enforcement, and engineering solutions.

The Task Force provided a Final Report and Recommendations to the Council at its April 4, 2016 meeting (REP28-16) entitled A Vision Zero Policy for Columbia, and a presentation was made to the Council at its November 7, 2016 Pre-Council Meeting. The presentation included the recommendation to establish a "Vision Zero" Policy with a goal of eliminating traffic deaths and serious injuries in Columbia by 2030.

Per the request of Council Member Thomas, a "Vision Zero" Policy has been drafted for Council consideration. It asserts that safety should be the most important factor in transportation planning, traffic deaths and serious injuries are preventable, and therefore, ethically unacceptable, and transportation systems should be designed and operated so that user errors are not fatal. It also directs the City Manager to review the recommendations with other parties and to design and present a Vision Zero Implementation Plan consistent with the guidelines presented in Exhibit A to the policy resolution no later than April 30, 2017.

There will be costs associated with this as the guidelines include at least a 0.50 FTE for a Vision Zero Program Manager and a new position for a Traffic Safety Engineer/Crash Analyst. In addition, the educational and enforcement implementation strategies will likely result in some costs. The definitive costs, however, are unknown at this time.

Fiscal Impact
